MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (MoU), is into on 4th April, 2022 (the Effective Date), by and between Principal & Secretary, Ujani Majuli Kherkatia College (UMK College), located at Nayabazar, Ratanpur Miri, Majuli (the First Party), and the Medical Officer, Ratanpur Miri Primary Health Centre (the 'Second Party'). First Party and Second Party may be referred to individually as the 'Party', or collectively, the 'Parties'.

1. MISSION

The partnership, on which the Parties are intending to collaborate, has the following intended mission in mind:

We agree to the fact that the Medical Officer, Ratanpur Miri Primary Health Centre will provide Ambulance and treatment support to the students, i.e., day scholars and hostel boarders and employees of UMK College on priority basis and on concessional rate. The bill for the aforesaid services will be reimbursed by the college authority within a period of one week.

2. OBJECTIVES

The Parties shall endeavour to work together to develop and establish policies and procedures that will promote and sustain a market for Medical Service to UMK College by Ratanpur Miri Primary Health Centre, and intend to maintain a product or service that meets or exceeds all business and industry standards.

3. RESPONSIBILITIES AND OBLIGATIONS OF THE PARTIES

Any Party may decide not to proceed with the partnership contemplated herein for any reason or no reason. A binding commitment with respect to the partnership described herein will result only from execution of definitive agreements, subject to the conditions contained therein.

The following are the individual services that the Parties are contemplating providing for the partnership,

- (i) Principal & Secretary, UMK College shall render and provide the following services that include, but aren't limited to the Payment of dues in time.
- (ii) The Medical Officer, Ratanpur Miri Primary Health Centre shall render and provide the following services that include, but aren't limited to providing Ambulance and medical treatment.
 - (iii) Ratanpur Miri Primary Health Centre will conduct health talks by various specialities and organize periodical free health check-up camps once a year at College premises on request of the first Party, request to be received 30 days in advance.



4. TERMS OF UNDERSTANDING

The terms of this Memorandum shall be for a period of five (5) years from the Effective Date and may extended upon written mutual agreement of both Parties.

5. LIMITATION OF LIABILITY

No rights or limitation of rights shall arise or be assumed between the Parties as result of the terms of this Memorandum.

6. NOTICE

Any notice or communication required or permitted under this Memorandum shall be sufficiently given if delivered in person or by certified mail, return receipt requested, to the address set forth in the opening paragraph or to such address as one may have furnished to the other in writing.

7. GOVERNING LAW

The Memorandum shall be governed by accordance with the law of state of Assam.

8. AUTHORIZATION AND EXECUTION

The singing of the Memorandum does not constitute a formal undertaking, and as such it simply intends that the signatories shall strive to reach, to the best of their abilities, the goals and objectives stated in this MoU.

This agreement shall be signed by Principal& Secretary, UMK College and the Medical Officer, Ratanpur Miri Primary Health Centre and shall be of date first written above.
